

healthcare system, which annually sustains huge costs for the treatment of chronic wounds (of non-hospitalized and hospitalized patients), would greatly benefit, from innovative low-cost hydrogel-based wound care solutions for routine use (Ramos et al. 2015; Sen et al. 2009).
